

Town of Swan River
Bylaw No. 3/2026

Being a bylaw of the Town of Swan River to establish a rate for the collection of residential waste and recycling material as a special service for the Town of Swan River for 2026.

WHEREAS Section 312 of *The Municipal Act* (hereinafter known as the "Act") of Manitoba, provides in part as follows:

312 If approved by by-law, a municipality may provide, as a special service to all or part of the municipality, the following:

(e) the collection and transportation of waste or recyclable materials;

AND WHEREAS subsection 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by By-law

- (a) approve the local improvement or special service as set out in the plan or proposal;
- and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS the Council of the Town of Swan River has prepared Special Service Proposal No. 3-2026 to establish a rate for the collection of residential waste and recycling within the Town of Swan River as a Special Service pursuant to Part 10 of the Act;

AND WHEREAS the requirements as prescribed in Sections 318, 319 and 320 of the Act have been complied with;

NOW THEREFORE the Council of the Town of Swan River enacts as follows:

1. That pursuant to subsection 320(1) of the Act, the Town of Swan River approves Special Service Proposal No. 3-2026 attached hereto as Schedule "A".
2. That the Town of Swan River levy an annual special service tax upon all benefiting properties within the Town as hereby described in Schedule "B".

Town of Swan River

Special Service Proposal No. 3-2026 For Collection of Waste and Recycling Materials on Residential Properties

(Pursuant to Section 314 of The Municipal Act)

Pursuant to Section 314 of *The Municipal Act*, The Swan River Town Council has deemed it necessary to continue to apply a special service levy upon all benefiting properties within the municipality for services described in Section 'A' below. Special Service Bylaw No. 3/2026 expires at the end of 2026 and replaces Special Service By-Law No. 7/2025 that expired at the end of 2025.

(A) Description of the Proposed Special Service

Proposed Special Service:

The Town of Swan River provides the following service:

- Residential Waste and Recycling Collection

The Council of the Town of Swan River wishes to establish a special service proposal for the collection of residential waste and recycling materials from benefiting properties within Town. Council is proposing to implement a per parcel tax on only those benefiting property owners. This special services proposal will apply for the year 2026.

(B) Area of Municipality for Special Service:

The Special Service Area to be levied under this proposal will be all residential properties (taxable, grant-in-lieu and otherwise exempt) containing one or more dwelling units receiving residential garbage and recycling collection, within the Town limits of Swan River as described in Schedule "B" attached hereto. Vacant and non-residential lots are excluded.

(C) Estimated Cost of the Service

The Town of Swan River provides the service and has done so for many years.

The costs are comprised of the actual costs of providing the services, subtracting any revenue attributable to these services such as Multi-Material Stewardship Manitoba (MMSM) funding.

Estimated costs are:

2026 \$440,000

The estimated cost of the service shall be determined by the following methodology:

2026 Year

Total cost of collecting residential waste material	\$ 198,000
Total cost of collecting residential recycling material	355,000
Total other revenue attributable to residential waste and recycling	<u>(113,000)</u>
Total taxation required to collect residential waste and recycling	<u>\$ 440,000</u>

D) Method and Rate of Calculating the Proposed Special Services Tax

The method of calculating the annual Special Service Tax will be a set amount per parcel of land based on the number of dwelling units within said parcel.

There are 1600 dwelling units (DU) in the Town of Swan River to which this bylaw applies.

E) Estimated Funds Generated by this Special Service Levy

The per parcel rates are based on volume and number of pick-ups within the Town of Swan River. The rates per parcel are as follows:

The 2026 per parcel rate of \$275.00 for single dwelling units is an increase of \$5.70 from the 2025 per parcel rate of \$269.30.
